### AVISTON AMERICAN LEGION AUXILIARY POST 1239

### SUBJECT: LEGION AUXILIARY VETERAN SCHOLARSHIP RESOLUTION

Adopted: December 2024 Revised:

This Resolution sets forth the rules, application, terms and guidelines for the Aviston American Legion Auxiliary Post 1239 Veteran Scholarship (the "Scholarship"). The purpose of the Scholarship is to honor individuals who have made a significant impact in the community. Applicants for this award shall be Veterans, Auxiliary or Sons of American Legion members or their spouses, children/step-children, grandchildren/step-grandchildren or great-grandchildren/step-great-grandchildren, of an Aviston American Legion, Post 1239, family. Any applicant, who is a Veteran, Auxiliary member or Sons of the American Legion member, must also be in good standing with the Aviston Illinois American Legion Family.

The Aviston American Legion Auxiliary Post 1239 (the "AALA") may provide a \$1,000 Scholarship, and the AALA intends to begin the Scholarship with the 2025-2026 School Year. A School Year is defined as beginning in the Fall of any given year and ending in the Summer of the following year. The AALA reserves the right to revise and/or amend the Scholarship as it deems necessary, including but not limited to the awarded Scholarship amount.

The Scholarship is to be used for post-secondary education, including but not limited to universities, colleges, vocational and technical schooling (the "academic institution"). The Scholarship may only be used for tuition and will be paid directly to the academic institution upon the AALA receiving: (i) an executed copy of a Letter Agreement from the applicant acknowledging his/her acceptance of the terms and conditions of the Scholarship, and (ii) a Statement from the academic institution that the applicant will be attending that identifies the school and sets forth the student's identity, his/her ID number and address, and the amount the student will be charged for tuition for the upcoming School Year (the "Statement"). If the Statement indicates that the amount due and owing is less than the Scholarship, only that amount will be paid to the academic institution. The winning applicant agrees

that in the event he/she does not complete the classes at the academic institution as planned during the School Year, arrangements must be made within thirty (30) days for the return to the AALA of the total amount of the Scholarship.

# **RULES GOVERNING THIS SCHOLARSHIP:**

- 1. The Applicant must be enrolled in post-secondary education at an academic institution for the upcoming School Year.
- 2. The application for the AALA Scholarship must be obtained from the Aviston American Legion website or in paper form from a member of the AALA Scholarship Committee.
- 3. The AALA will appoint a Scholarship Committee to serve as judges. Judging will include, but may not be limited to the applicant's:
  - A. CHARACTER/LEADERSHIP: High standard of conduct; keen sense of right; strength of character; adherence to truth, principles and conscience; volunteerism; ability to lead and to accomplish through group action, personal magnetism, guidance and consideration of other individuals.
  - B. ESSAY: Content, spelling and grammar of a submitted essay.
  - C. SCHOLARSHIP: Certified copies of either a high school or postsecondary school transcript that indicates the grades and/or ranking that the applicant received upon completing either high school or postsecondary classes to date, with an explanation of the status on where the applicant is in reaching his/her goal, e.g., completed two years of college in pursuit of a goal of obtaining a bachelor's degree. Information on the degree that the applicant is seeking and how he/she are or will apply that degree to their current and/or future employment.
  - D. INTERVIEW: Prior to the award of the Scholarship, the Scholarship Committee will interview the top applicants.
- 4. The winning applicant will be notified of the results by August 1st of the upcoming School Year. The Scholarship will be paid within thirty days to the academic institution upon receipt of: (i) an executed copy of a Letter Agreement from the applicant acknowledging his/her acceptance of the terms and conditions of the Scholarship, and (ii) a Statement from the academic institution that the applicant will be attending that identifies the school and sets forth the student's identity, his/her ID number and address, and the

amount he/she will be charged for tuition for the upcoming School Year (the "Statement").

5. The applicant is limited to only ONE SCHOLARSHIP award by the AALA per School Year. Applicants are permitted to reapply for a Scholarship in any subsequent School Year, but the reapplication must include verification of the completion of the course work for any prior School Year.

# **APPLICATION REQUIREMENTS:** The applicant must include the following:

1. A completed application must be post-marked and/or received by April 1st preceding any School Year addressed to:

- 2. Three (3) executed letters of recommendation or reference dated within the preceding calendar year, from individuals, such as:
  - a. Community Directors;
  - b. Faculty or administration officials from high school and or post-secondary institutions, e.g., a counselor, advisor and/or department head;
  - c. Clergy or church official; and/or
  - d. An adult citizen, other than a relative, attesting to the applicant's character in regards to conduct, citizenship and/or leadership.
- 3. A listing and description of the community or volunteer activities/ involvement and hours that the applicant has been involved with during the last calendar year.
- 4. An original essay written by the applicant on: <u>"What I learned from</u> <u>"Interviewing" a current military member or Veteran"</u>. It is recommended that the essay be typewritten, contain a cover page and consist of no more than 750 to 1,000 words in a double space format.
- 5. The most recent certified transcript from either the applicant's high school or post-secondary education institution.

- 6. A brief statement of the military service of the Veteran under which the application is being submitted. The statement must include the branch of service and dates of service or a photocopy of the Veteran's DD214.
- 7. Top applicants will be assigned an interview time to meet with the Scholarship Committee.
